**FACTS** The plaintiff was the estate of Gertrude Hollins, who died at age 89 after residing in a Longview nursing home for 32 months. Hollins' nephew, on behalf of her estate, sued the owners and managers of Cleaver Memorial Convalescent Centers, as well as numerous affiliated companies; five nurse employees; a registered dietician whose identity is protected by a confidentiality agreement, and Sita Devulapalli. Sita Devulapalli, Hollins' physician, for gross negligence. Neither the dietician nor Devulapalli were employees of the home.

The lawsuit alleged that the nurses failed to turn and reposition Hollins and ignored Hollins' severe and ongoing pain caused by massive pressure sores. It claimed that the home engaged in a pattern and practice of dangerous understaffing, destroyed personel files and time cards to cover up the understaffing, sought heavy-care patients despite understaffing, and falsified

staffing records. The home generally denies these allegations and argued that the

Devulapalli stated that it was one of the worst cases of neglect that she had ever

seen, said the plaintiff's attorneys. Also, they said, the Texas Department of Health and Human Services cited the home for neglect of Hollins and repeatedly warned it about dangerous care practices.

In deposition, charge nurses and the dietician testified that the home grossly

neglected Hollins. The dietician also testified that the nurses were grossly

negligent.

The plaintiff alleged that the dietician failed to monitor Hollins' caloric intake properly and failed to make appropriate dietary recommendations.

The dietician denied any wrongdoing by her. The home failed on numerous

ambulate, was stable, and had no history of pressure sores, dehydration, malnutrition or end stage disease.

During her residency, she allegedly developed a 10-inch diameter, stage IV sacral/coccyx pressure sore that was infected and had sloughing, yellow drainage;

Although her physician, Sita Devulapalli, had determined that she needed nursing

developed a total of eight avoidable in-house pressure sores; was hospitalized four times for dehydration; and lost 90 pounds in two years. She allegedly suffered excruciating, continuous pain for the last eight months of her residency, at the end of which she died. The estate claimed \$95,765 in medical bills and also sought punitive damages.

Devulapalli said that she had no doubt that Hollins had experienced "severe and provided that the last end of the same and the life and the damages."

Devulapalli said that she had no doubt that Hollins had experienced "severe and unrelenting pain" for over seven months "from the deep, eroding pressure sores," said the plaintiff's attorney Jacques Balette. According to Balette, Devulapalli said that she was never informed by the home that her orders were not being followed, and that every time she called the home, they would lie to her, but that she later found out what was really happening.

The defense argued that the injuries were clinically unavoidable, said Balette.

RESULT

The case settled before trial for \$5.3 million. Devulapalli was dismissed without any payment.

The attorney for the nursing home employees and entities was telephoned for comment, but did not respond.
